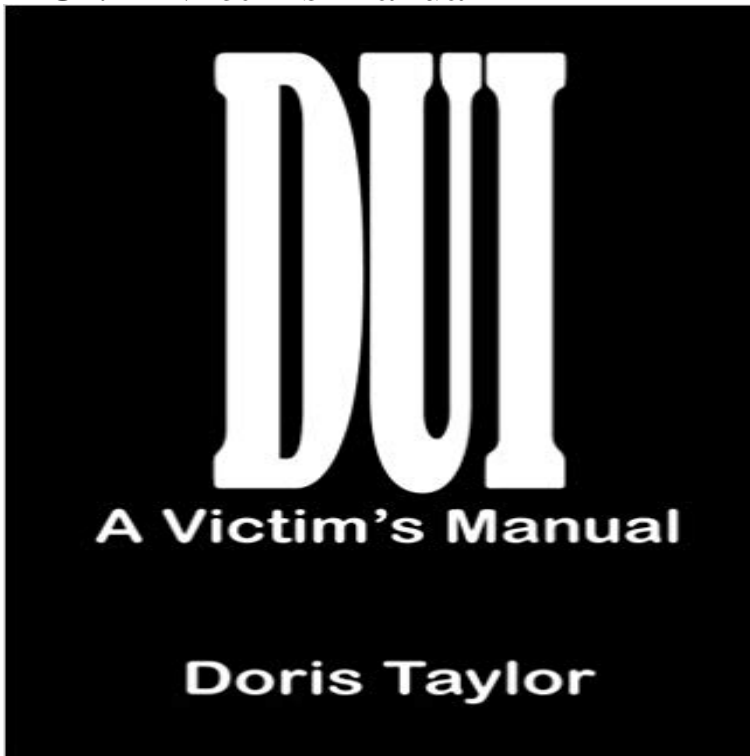


DUI: A Victims Manual
