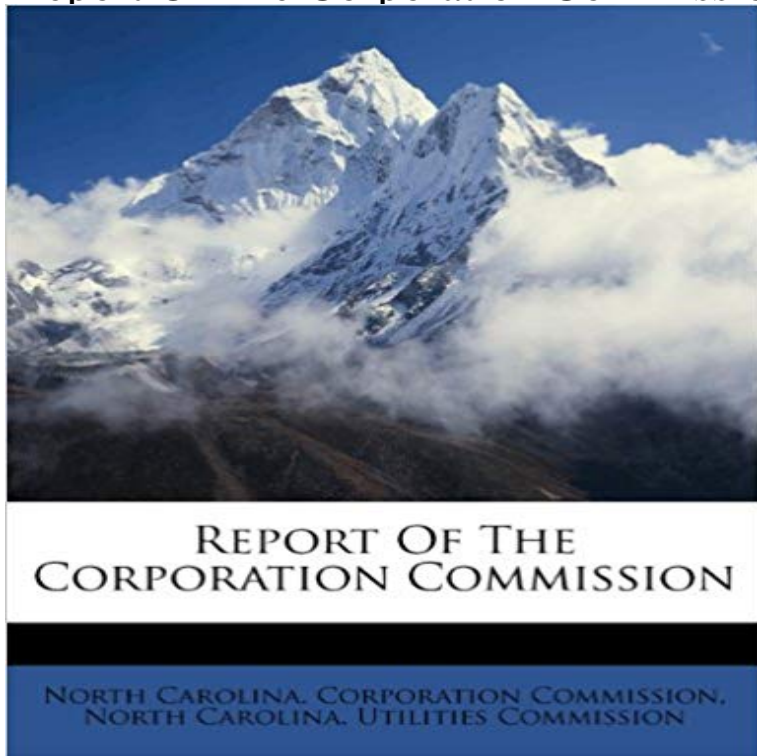


# Report Of The Corporation Commission
