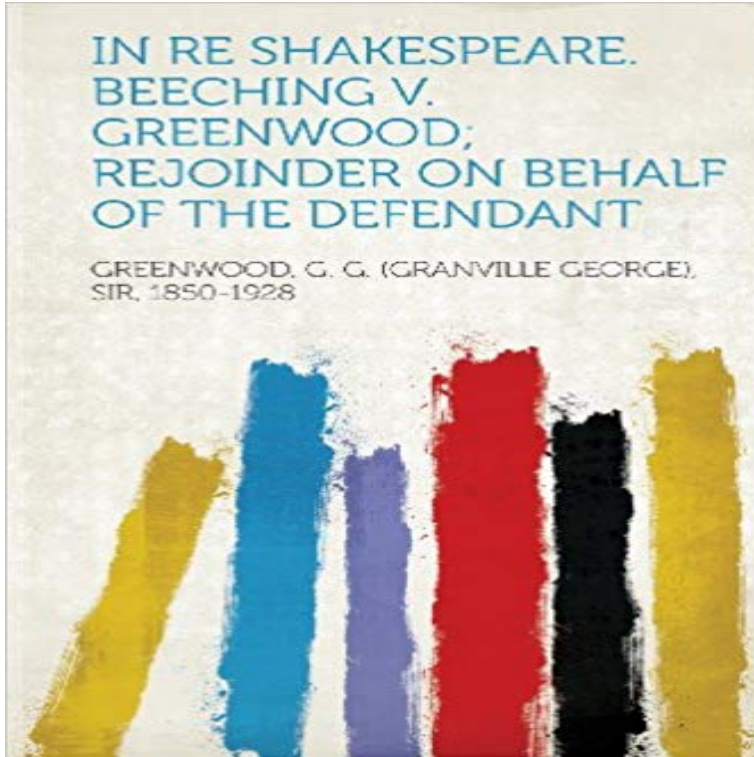


# In Re Shakespeare. Beeching V. Greenwood; Rejoinder on Behalf of the Defendant
