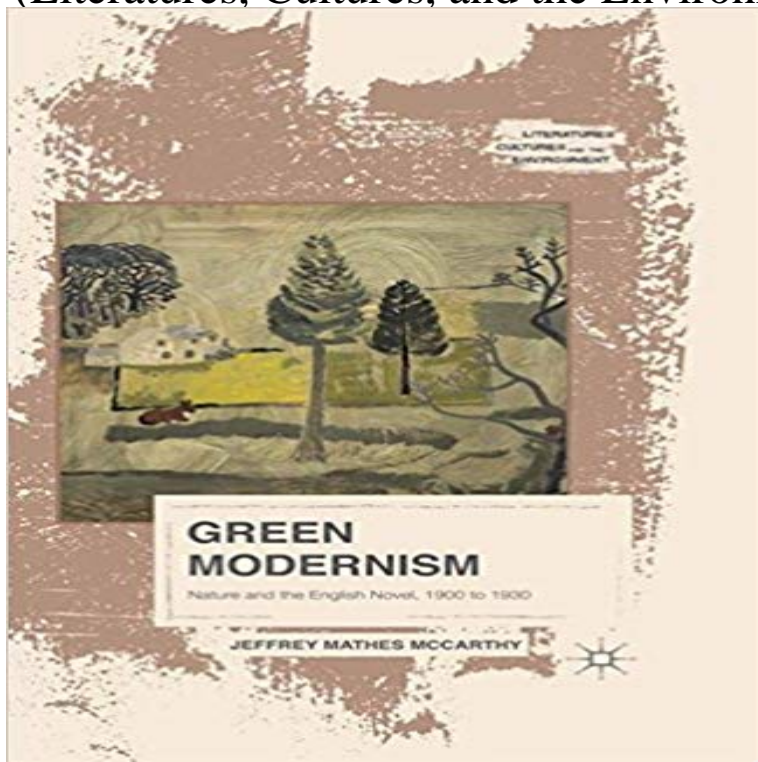


Green Modernism: Nature and the English Novel, 1900 to 1930 (Literatures, Cultures, and the Environment)
