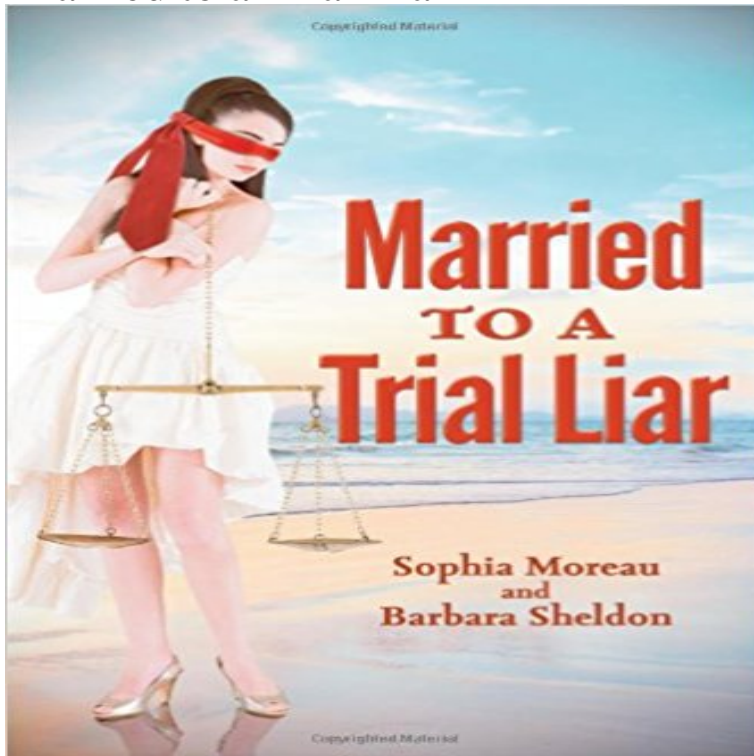


Married to a Trial Liar



Married to a Trial Liar is a wonderfully creative page-turner that chronicles the rags-to-riches account of Mia Picarde, a successful Long Island, New York, businesswoman who battles her way out of deprivation and domestic violence to be somebody, only to find herself in the fight of her life with sociopathic husband Dave Grossman who refuses to divorce her, and whose relentless obsession with her rules his world and threatens to destroy them both. The story unfolds as Mia prepares for a court appearance in an ongoing effort to divorce Grossman. A visit to the scattered remains of her family's home in Long Beach triggers a series of flashbacks detailing Mia's humble beginnings. Growing up poor and hungry and living a hard-knock life only serves to strengthen her resolve and belief in forging a singular path to a better place. However, her accidental and repeated entanglements with abusive, narcissistic men lead her on a journey she is ill-prepared to take. Mia's first husband is the opening act for a roller-coaster ride that brings her to the edge of darkness. His alcohol and drug use send her running to the nearest exit. The second detour on that ride is a meeting with attorney Dave Grossman whom she consults for legal help with divorce and bankruptcy woes, and ultimately marries. It's not long before his abusive behavior, sexual perversions, and blatant infidelity escalate, causing her self-worth to plummet. A call from Dave's mistress--who shares bone-chilling stories of sexual dominance, emotional and physical abuse, and his for red ties--leads Mia to the realization that he is evolving from obsessed husband to sexual predator to possible serial killer. A sequence of events -- involving a Mickey Spillane type private investigator, a reluctant chief of detectives, a phalanx of angels, and an Italian businessman who comes to Mia's rescue and falls in love with her -- culminates in

the final, surprising denouement as all plot threads converge in the village of East Hampton on the tony east end of Long Island.
