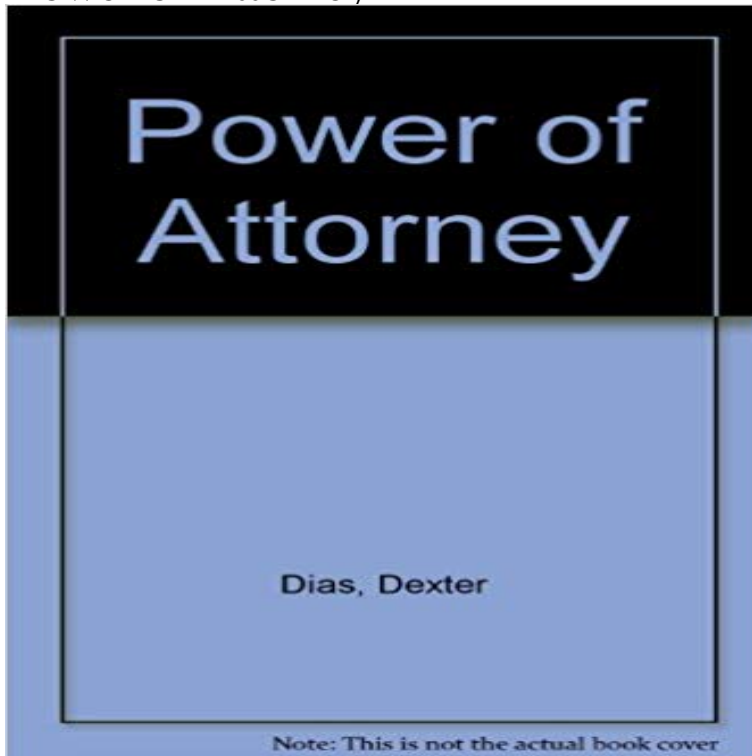


Power of Attorney
