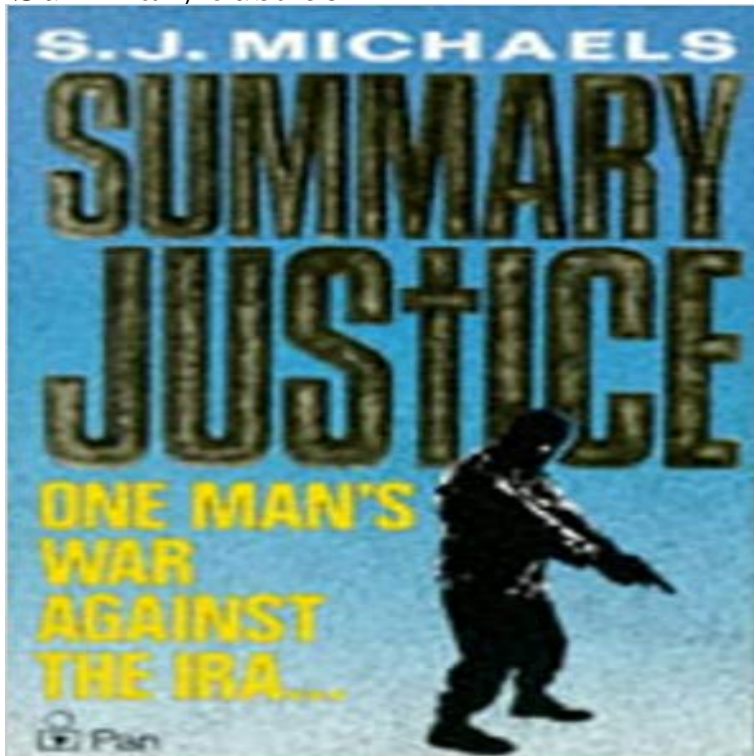


Summary Justice
