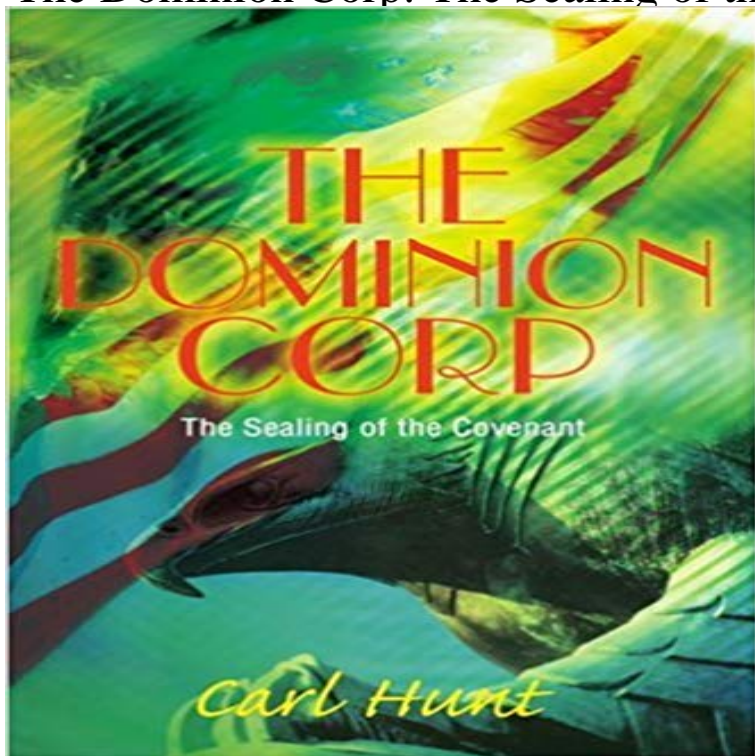


The Dominion Corp: The Sealing of the Covenant
